



Alternative Show **EXPECTATIONS** between the Artist, the Venue and PAAG

- **ORIGINAL ART** is to be displayed.
- **PAAG** assists in coordinating the **ARTIST** with the **VENUE**.
- **VENUE** reserves the right to reject any work not deemed acceptable to them.
- **ARTWORK HANGS** for approximately 6 weeks

SHOW DATES & TIMES . INSTALLATION REQUIREMENTS . TAKE DOWN

- **ARTIST** contacts the **VENUE** to schedule **SHOW DATES** and **TIME**
- **ARTIST** **HANGS** their own work. **PAAG** **MAY BE** there to assist.
- **ARTIST** checks with **VENUE** if they have **WEIGHT** or **SIZE LIMITS** for hanging.
 - **ARTWORK MUST BE WALL-HUNG.**
 - **FRAMED** and **WIRES** – **SAW TOOTH HANGERS** are **NOT ACCEPTABLE.**

LABELS, ARTIST STATEMENT, BUSINESS CARDS

- **ARTIST** provides:
 - **LABELS** for the **WALL** and for the **BACK OF THE ART** with the **TITLE** and **PRICE** (tax included)
 - **BUSINESS CARDS** for the front reception counter and in the area of the exhibit.
 - **ARTIST STATEMENT** suggested hanging along with the artwork.

RECEPTION & ARTIST TALK

- **ARTIST** contacts the **VENUE** to schedule the **RECEPTION DATE** and **TIME**
- **ARTIST** is encouraged to set up an **ARTIST TALK** with the **VENUE**. It can be used to describe your process or inspiration for the artwork.

SALES

- **PRINTS** of displayed original art can be made available.
- **SMALL ITEMS** can be included for sale **AT THE RECEPTION** - ie. Notecards, Merchandise with your images printed on them.

- ARTWORK may be FOR SALE or NFS (Not for Sale).
- SALES will need to be done directly between the artist and the buyer through DIRECT CONTACT WITH THE **ARTIST** by Phone or a Venmo QR Code.
- ARTIST is responsible for collecting and submitting sales tax.
- SOLD PIECES may be REPLACED with another piece of comparable size.
- **VENUE** WILL NOT HANDLE Cash Sales
- **VENUE** will not hold any artwork or payments for artwork.
- ARTIST will arrange for delivery of the artwork directly with the purchaser.
- ARTWORK should not be left at the venue to be picked up.

COMMISSION FEES

- **VENUE** does NOT TAKE A COMMISSION; however, a donation may be offered to a Non-Profit Organization at the VENUE
- **PAAG** - A 10% Donation of Sales is suggested.

PROMOTION

- **PAAG** advertises the show, reception, and art talk on its Social Media and Website. PAAG will need images of your art.
- **VENUE** may also want to advertise the event with images of you or your art.

LIABILITY

- **PAAG** nor **VENUE** assumes NO responsibility for theft or damage to the artwork.
- **ARTIST** assumes ALL responsibility for stolen or damaged artwork.
